

Campus safety is a shared responsibility that depends on all of us staying alert and aware. By recognizing and reporting potential threats or hazards, you help us strengthen our safety and security efforts. If you see something, please say something—your awareness and willingness to speak up could provide the crucial information needed to prevent or resolve a potentially unsafe situation.

We continue to make continuous improvements to our safety and security systems. In the past year, WCCC continued to expand our training efforts with our campus community and the local law enforcement community. We installed additional safety equipment and tested all existing equipment on an ongoing basis to ensure it functions properly in the event of an emergency. The College Critical Response Team remains resolute in ensuring updates to our campus safety plan are being made as necessary to ensure that our protocols align with current industry standards and best practices. The College also continues to update and enhance our communication systems to ensure that appropriate information is disseminated in a timely manner during emergencies. This year, we installed additional alarms, the Visiplex system was completed and is currently functioning within each dorm on campus to notify students in the event of an emergency. This is another layer of enhanced protection meant to communicate with students to alert you of incidents that happen in real time on our campus. We contracted with Dirigo Safety and the American Red Cross, to conduct campus safety and security trainings for our faculty, staff and students.

Our Annual Safety and Security Report offers essential information about the safety and security of our campus. We encourage you to review its contents, as the guidance it provides may be vital to your personal safety while at the College. By staying informed and engaged, we can continue working together to strengthen prevention measures and keep our campus community safe.

CLERY ACT

Annual Safety and Security Report

The Washington County Community College (WCCC) Annual Safety and Security Report is published in compliance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act ("Clery Act"), the Higher Education Opportunity Act of 2008, the Violence Against Women Act (VAWA), and the Stop Campus Hazing Act of 2024. This report includes statistics for the previous three years concerning reported crimes that occurred on campus and on public property within, or immediately adjacent to and accessible from the campus. The statistics include crimes reported directly to local law enforcement agencies and to "campus security authorities." Campus security authorities are defined by the Clery Act as college officials who have "significant responsibility for student and campus activities, including, but not limited to, student services, residence life, and the campus safety and security team. The report also includes institutional procedures concerning campus safety and security, alcohol and drug use, crime prevention, the reporting of crimes, sexual assault, and other matters. These processes are reviewed annually to assess their effectiveness and compliance with applicable statutes.


OVERVIEW

The policies and procedures outlined in this report are provided as part of WCCC's commitment to safety and security on campus and are in compliance with the Clery Act of 1998. WCCC is a public college located in Calais, Maine, and is one of seven campuses that comprise the Maine Community College System (MCCS). There are approximately 800 students enrolled at the College, which employs approximately 60 faculty and staff members.

There have been many recent steps taken to improve security on campus, including:

- additional access controlled doors and propped-door monitoring technology
- continued membership and additional training for college officials through the National Association of Behavioral Intervention and Threat Assessment
- the creation of a Campus Safety Department within the Enrollment and Student Services Division
- the creation of a full-time Campus Safety and Security Office position

The Campus Safety Committee meets on a monthly basis to discuss agenda items related to the safety and security of the WCCC campus.





CLERY ACT REPORTING

Publication of this annual report is mandated by federal law. The annual crime statistics were compiled through the Office of Enrollment Management and Student Services. The report includes statistics for the previous three years concerning crimes that occurred on campus and were reported to local law enforcement agencies and to "campus security authorities" or designated campus officials. Additionally, these statistics include people referred for campus disciplinary action for categories required under the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, including liquor and drug law violations and illegal weapons possession. Statistical information for certain off-campus locations or property owned or controlled by the College, as well as public property within or immediately adjacent to and accessible from campus, are collected or requested from local police departments.

Each fall, e-mail notification is made to the WCCC community (faculty, staff, and enrolled students) to distribute the Campus Crime and Safety Report. The report is also included on the Human Resources and prospective student web pages to inform prospective employees and students. The crime statistics tables in this report are reflective of the requirements mandated by federal law for compiling this annual publication. The annual crime statistics compiled in this report originate with data kept by the Office of Enrollment Management and Student Services.

TIMELY WARNINGS AND EMERGENCY NOTIFICATIONS

WCCC is committed to promoting a safe and secure environment for all members of the college community.

Timely Warnings: In compliance with the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (Clery), WCCC will post timely warnings to notify community members about serious crimes that occur on campus. Having knowledge of such crimes will assist the community members in making informed decisions about their personal safety and in preventing or reducing the risk of future crimes. These warnings are posted if there is a serious crime on campus that constitutes an ongoing and/or continuing threat to the community. Timely warnings are not issued for crimes where the suspect(s) has been apprehended. The decision to issue a timely warning is decided on a case by case basis in compliance with the Clery Act. The decision is made by the Dean of Student and Enrollment Services or designee. A timely warning will take into account available facts, whether the crime is considered serious, a continuing threat to the community, and/or the possible risk of compromising law enforcement. A timely warning will not include identifiable information of a victim. WCCC considers issuing a timely warning for the following incidents: criminal homicide, sex offenses, aggravated assault, robbery, burglary, motor vehicle theft, major incidents of arson, and other crimes as determined necessary by the President or designee(s). Individuals that can make timely warning decisions include President, Dean of Enrollment Management and Student Services, Academic Dean, and Director of Facilities.

Timely Warnings and Updates Distribution: Procedures and mechanisms to notify the campus community are in place including the use of the Rave Alert System.

Emergency Notifications: Unlike Timely Warnings, Emergency Notifications are used when there is an emergency that is not a Clery crime category. Procedures and mechanisms to notify the campus community are in place and include the use of the Rave Alert System and Vigilance System. All WCCC Employees are empowered to activate the emergency notification system (through their mobile phone or computer) to provide pre-determined immediate alerts during critical incidents. WCCC utilizes an external loudspeaker and an internal intercom system to disseminate information. In addition, WCCC utilizes social media and the website to notify the greater Calais community of incidents on campus. The Critical Response Team collaborates with local authorities to confirm significant emergencies and dangerous situations and provide continued messaging to the campus community.

Testing Emergency Procedures: WCCC will perform tests multiple times a year and document each test with a description of what it was, whether it was announced or unannounced, and the date/time if was conducted. Emergency policies and procedures are found at www.wccc.me.edu/safety-and-security.

Safety Programs and Promoting Crime Prevention

Security awareness and crime prevention programs are part of WCCC's effort to provide a safe environment for students and employees. The College's educational and crime prevention efforts are based upon the concepts of eliminating or minimizing criminal opportunities whenever possible, and encouraging students and employees to be responsible for their own security and the security of others.

The following is a listing of the crime awareness and prevention programs:

- Electronic Material: Sexual harassment brochures are provided electronically to all students, faculty, and staff along with the Clery Reporting information.
- Residence Hall Safety: A variety of programs are offered for students living in the residence halls covering topics on safety awareness, sexual assault and date rape prevention, dating violence, stalking, and domestic violence, fire safety, drug and alcohol awareness programs, and mental health. Prevention is stressed but response to these concerns is also an important consideration.
- Fall Orientation: Sessions at fall orientation address the Maine Community College System polices, WCCC procedures, and sexual misconduct policies.
- Sexual assault, dating violence, domestic violence, and stalking educational campaigns are held throughout the year.



OFF CAMPUS CRIME

The Calais Police Department routinely works and communicates with the WCCC Office of Campus Safety on incidents occurring in the immediate neighborhood and business areas surrounding our campus. Off-campus and non-campus student violations of the law or the Student Code of Conduct are addressed by the Student Code of Conduct policy. The College works collaboratively with the CPD and frequently exchange information when appropriate.

REPORTING SUSPICIOUS ACTIVITY

Students and employees are urged to contact WCCC personnel and/or the Calais Police Department if they notice unusual, suspicious or criminal activity. Suspicious individuals should be reported to campus officials or local law enforcement, especially if they are seen:

- Attempting to enter a residence hall or a student's room
- o Entering an office or lab without apparent purpose
- Loitering in a parking lot, near residence halls or offices
- Trying to forcibly enter a car, window or door
- Acting in a loud, disruptive or threatening manner

LAW ENFORCEMENT AUTHORITY AND INTERAGENCY RELATIONSHIP

State laws require that WCCC officials must report certain crimes including child and elder abuse, among others. WCCC has a working relationship with the Calais Police Department and may disclose information the Calais Police Department as warranted to ensure campus safety. In addition, there is a duty on the part of the employees at WCCC (who are not exempt by due to State Law—e.g. counselors, pastors) to report disclosures of sexual harassment, sexual assault, stalking, and domestic violence that occurred on campus property and/or involved a WCCC community member to the Title IX Coordinator. Student incidents should be reported to the Dean of Student Services— Title IX Coordinator at (207) 454-1000. Students may access pastoral and professional counselors, when appropriate, to report a crime in confidence as WCCC adheres to state and federal law regarding confidentiality.

FIREARMS

In accordance with the policy of the Maine
Community College System, no person
(except law enforcement acting in their
official capacity) may possess a firearm on the
WCCC campus. This prohibition includes
residence halls and motor vehicles parked on
college property.

BUILDING MAINTENANCE, SECURITY, AND ACCESS

WCCC is committed to maintaining a safe environment which extends to maintenance issues such as campus landscaping, lighting and door locks. Exterior lighting is maintained throughout campus. Physical Plant and Student Services routinely surveys existing lights and recommend maintenance of existing lights and requests for additional illumination, if necessary. The campus is equipped with exterior and interior cameras. Facilities continually checks for maintenance and security deficiencies and strives to maintain a safe environment. Members of the campus community are encouraged to report any deficiency to Tina Erskine, Manager of Operations & Human Resources, at (207) 454-1002.

In addition to lighting and campus cameras, Facilities routinely checks to ensure campus building doors are secured. WCCC buildings, excluding residence halls, are accessible to members of the campus community, guests and visitors during normal operating hours Monday through Friday. Entry after normal hours is available to faculty, staff and authorized students, as determined by the appropriate academic or administrative offices. Buildings are also opened on weekends and holidays on an as-needed basis. All residence halls, which are apartment style, are secured 24/7 with a keys issued to each residential student.






CAMPUS SAFETY AND SECURITY AUTHORITY

College officials have the authority to ask persons for identification and to determine whether individuals have lawful business at WCCC. No WCCC personnel are authorized to arrest. Criminal incidents are referred to the Calais Police Department who have jurisdiction at WCCC, and to the Dean of Enrollment Management and Student Services Office for possible disciplinary action. All crime victims and witnesses are strongly encouraged to immediately report any crime to student services and/or the Calais Police Department. Prompt reporting will ensure communication of Campus Crime Alerts to the campus community and the accurate disclosure of Clery Act crime statistics.

When a WCCC student is involved in an off-campus offense, campus officials may assist with the investigation in cooperation with the local police department. The Calais Police Department routinely works and communicates with the WCCC Office of Campus Safety on incidents occurring oncampus, in the immediate neighborhood and business areas surrounding our campus.



EVACUATION PROCEDURES

If a building evacuation is determined to be the best course of action, supervisors must inform all employees of the evacuation plan. In addition, a security sweep of the egress route, rally points used for assembly and surrounding areas should be performed. Employees must be familiar with evacuation plans for the buildings in which you are located or visiting. When entering an office or other environment check for the evacuation directions. All employees are empowered to activate emergency notifications for campus evacuation protocols directly from their desktop computer using the Vigilance system.

All faculty members are responsible for reviewing the evacuation plan for classrooms and shops with all students at the beginning of each semester.

- 1. Evacuation maps with primary exit routes and designated rally points are posted in classroom, shops, and college areas in the event an evacuation of the building becomes necessary.
- 2. Except for medical emergencies, elevators should not be used for emergency evacuation.
- 3. Special health problems and needs (such as a "handicapped accessible" means of evacuation) need to be addressed in advance by contacting Accessibilities Specialist in order to make proper provisions for these individuals.
- 4. All should follow the procedures outlined below in case it becomes necessary to evacuate the building.
 - a. Remain calm.
 - b. Keep talking and confusion to a minimum.
 - c. Exit in an orderly fashion with no more than two people side-by-side. Walk, do not run to exits.
 - d. Close all doors as you leave.
 - e. Do not jam or crowd exits.
 - f. Use the stairwells for evacuation.
 - g. Assist any persons with disabilities or notify emergency personnel of their location.
 - h. Once outside the building find a safe area with concealment and cover until you receive the all-clear message and then proceed to the designated rally point for your location. Conduct a head count, for your class and/or office, to make sure that no one is missing. Report any missing persons to (207) 454-1099, when safe to do so. Designated rally points for assembling from different parts of each building are given in each classroom.
 - i. You will be notified by proper authorities when it is safe to return to your building.





DRUGS AND ALCOHOL

The use, possession, sale or distribution of alcoholic beverages or illegal drugs is prohibited on college property or at college related events, as is being under the influence or knowingly in the presence of drugs or alcohol while on college property or at college-related events under the Student Code of Conduct. Individuals who violate this policy and/or federal or state law, including laws and policies pertaining to underage drinking, risk institutional sanctions, including dismissal from the College and/ or legal action.

WCCC prohibits the possession or use of illegal drugs or alcohol on the campus, property owned or controlled by WCCC, or as part of any activity of WCCC. Legal possession or consumption of alcohol on campus may be granted by obtaining the prior written approval from the College President. Students, staff, faculty, or visitors are prohibited from attending their work and/or learning environments under the influence of alcohol or illegal drugs. Doing so would not only negatively affect the individual's learning, performance, and safety, but also that of the people around them and the college community as a whole. Individuals who violate this policy and/or federal or state law risk institutional sanctions, including dismissal from the College and/or legal action. For more information about drug and alcohol policies on campus, please consult the Maine Community College System Alcohol & Drugs Policy (804).

Alcohol and substance abuse negatively impairs health and life quality. Local, state, and federal laws prohibit the underage, unlawful possession, use, sale or distribution of alcohol and drugs. In support of all local, state, and federal laws, WCCC's Student Code of Conduct and employment policies enforce alcohol and drug laws.

Medical Marijuana: Federal law and the Drug Free Schools and Workplace Acts make possession and use of marijuana on- campus illegal, even in states with medical marijuana laws. Thus, WCCC does not permit medical use of marijuana anywhere on campus.

While WCCC does not offer substance/alcohol abuse programs, professional and confidential counseling is available to students on campus through an agreement with Aroostook Mental Health Center. Please contact Student Services at (207) 454-1000 for more information or to schedule an appointment.

Students (who have alcohol or other substance abuse issues) are also strongly encouraged to contact their medical provider or, if in crisis, the Maine Statewide Crisis Hotline at (888) 568-1112. Students may also request that Student Services staff make this contact for them.

VIOLENCE AGAINST WOMEN ACT (VAWA) RESPONSE TO DOMESTIC VIOLENCE, DATING VIOLENCE, SEXUAL ASSAULT AND STALKING

Sex discrimination and sexual misconduct in the form of hostile work environment, sexual harassment, domestic violence, dating violence, stalking, sexual violence (rape, sexual assault, and sexual abuse), and gender/sex-based harassment or discrimination, represent conduct that is prohibited by WCCC/MCCS policy as those terms are defined for purpose of the Clery Act and in accordance with Title IX.

This section of the report informs the campus community of WCCC programs designed to address domestic violence, dating violence, sexual assault and stalking. This section also includes the procedures for institutional disciplinary action in cases of alleged dating violence, domestic violence, sexual assault or stalking, when it is reported to a college official.

WCCC offers training related to sexual misconduct (VAWA, Title IX, Campus SaVE Act) at an in-person and online orientation and education and bystander events, including domestic and dating violence risk reduction; reporting of sexual harassment incidents; and education on sexual harassment to students, faculty, and staff. WCCC provides educational bulletin boards for students to access information and the website contains information regarding Title IX and sexual harassment.



PROCEDURE ON SEXUAL ASSAULT

Any behavior that constitutes a sexual assault under this policy will subject the offender to disciplinary action, up to and including dismissal, whether or not criminal charges are filed and without regard to whether the conduct occurred on or off campus. In addition, sexual assault, rape and other sexual offenses are illegal under Maine criminal statutes and may be separately prosecuted in a court of law.

REGISTERED SEX OFFENDERS

In compliance with the Campus Sex Crimes
Prevention Act of 2000, members of the
WCCC community may contact the Maine
Sex Offender Registry at their website
http://sor.informe.org/sor/
for information concerning
registered sex offenders.

Sexual assault occurs in instances of rape, fondling, incest, or statutory rape. Rape is the penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim. Fondling is the touching of the private body parts of another person for the purposes of sexual gratification, without the consent of the victim. Consent requires mutually understandable and communicated words and/or actions demonstrating agreement to participate in the proposed sexual act. Failure to object does not constitute consent. Consent does not exist where it is not expressly given. Consent cannot be given by a person who is underage; asleep; intoxicated; or when they are temporarily or permanently incapacitated. Consent can also not be given where there are threats or intimidation. Attempted sexual assault or rape occurs when a person intends to commit the offense and engages in conduct that could lead to it.

The College can refer victims of sexual offenses to counseling support and police assistance, if desired. Care and consideration of the victim's wishes will be taken into account throughout the intervention process. Individuals who feel that they are victims of any sexual offense are urged to file a complaint with the Calais Police Department and with the Dean of Students/Title IX Coordinator. The reporting party has the option to notify local law enforcement and the College can assist, if the reporting party so chooses, but they are not required to notify such authority.

The College strongly recommends that all victims seek immediate medical assistance and preserve all physical and digital evidence. A victim may have internal or external injuries and may need treatment for disease or infection. Additionally, the College strongly recommends that all victims seek counseling and emotional assistance. A full range of support services can be initiated through the Sexual Assault Crisis Center by calling (800) 871-7741.

WCCC's standards of conduct and the student disciplinary process are outlined in the Student Code of Conduct. The college's procedures for disciplinary action in cases that involve sexual offenses comply with Title IX of the Education Amendments of 1972 the Higher Education Amendment (HEA) of 1992 and the Violence Against Women Act of 1994 and Maine State Law LD1727. In those cases required by the HEA and VAWA, the accuser and the accused are entitled to the same opportunities throughout the investigative and disciplinary process, including to have others present during the investigative interview and/or during an Appeal Committee hearing and attendant proceedings. Maine law prohibits conduct that falls within the broad definitions of sexual violence and intimate partner violence, as well as stalking. These categories of conduct are similar to those prohibited by Title IX, but the definitions differ. In addition, unlike Title IX, these categories are not included within the state definition of sexual harassment. The definitions of sexual violence, intimate partner violence and stalking as defined by Maine law are set forth below and in Procedure 202.2.

DEFINITIONS OF SEXUAL VIOLENCE, INTIMATE PARTNER VIOLENCE, AND STALKING

Sexual Violence

"Sexual Violence," as defined in 20-A MRS §12981(8), encompasses a range of crimes under the umbrella of sexual assault, unauthorized dissemination of private images, sex trafficking or aggravated sex trafficking, as well as sexual harassment, as defined herein.

- <u>"Sexual Assault"</u> means any crime under 17-A MRS Chapter 11, and broadly includes a range of unlawful sexual conduct, including <u>gross sexual assault</u> (commonly referred to as "rape,"), <u>unlawful sexual contact</u> or <u>unlawful sexual touching</u>. For purposes of defining sexual assault, the following state law definitions of "sexual act" "sexual contact" and "sexual touching" apply:
 - "Sexual Act" means:
 - Any act between 2 persons involving direct physical contact between the genitals of one and the mouth or anus of the other, or direct physical contact between the genitals of one and the genitals of the other;
 - Any act between a person and an animal being used by another person which act involves direct
 physical contact between the genitals of one and the mouth or anus of the other, or direct physical
 contact between the genitals of one and the genitals of the other; or
 - Any act involving direct physical contact between the genitals or anus of one and an instrument or device manipulated by another person when that act is done for the purpose of arousing or gratifying sexual desire or for the purpose of causing bodily injury or offensive physical contact. Conduct constituting a sexual act does not require but may include penetration. The crime of gross sexual assault requires a sexual act.
 - <u>"Sexual Contact"</u> means any touching of the genitals or anus, directly or through clothing, other than as would constitute a sexual act, for the purpose of arousing or gratifying sexual desire or for the purpose of causing bodily injury or offensive physical contact.
 - <u>"Sexual Touching"</u> means any touching of the breasts, buttocks, groin or inner thigh, directly or through clothing, for the purpose of arousing or gratifying sexual desire.
 - Under Maine law, sexual contact and sexual touching are unlawful. A sexual act constitutes gross sexual assault when, at the time of the conduct, an additional element is present, including when the person:
 - Has not expressly or impliedly acquiesced to the sexual activity and the other person was <u>criminally negligent</u> with regard to whether the complainant acquiesced;
 - Is unconscious or physically incapable of resisting and has not consented to the sexual conduct;
 - Has a mental disability that is reasonably apparent or known to the other person that renders the
 person substantially incapable of appraising the nature of the contact involved or of understanding
 the right to deny or withdraw consent;
 - Is under the statutory age of consent for the nature of the sexual conduct and was not the actor's spouse;
 - Submitted as result of <u>compulsion</u> (gross sexual assault only);
 - Was compelled or induced to engage in the sexual act by any threat by the other person (gross sexual assault only); or
 - Has been furnished with drugs or alcohol by the other person which resulted in substantial impairment of the person's power to appraise or control their sexual acts (gross sexual assault only).
 - Sexual assault for purposes of this definition also includes sexual crimes against minors, including crimes of <u>visual sexual aggression against a child</u>, sexual abuse of a minor, <u>sexual misconduct with a</u> <u>child under 14 years of age</u>, <u>solicitation of a child to engage in a prohibited act</u>, and <u>solicitation of a</u> <u>child to engage in prostitution</u>.

- <u>"Unauthorized Dissemination of Certain Private Images"</u> means to intentionally harass, torment or threaten the depicted person or another person, knowingly disseminates, displays or publishes a photograph, videotape, film or digital recording of another person in a state of nudity or engaged in a sexual act or engaged in sexual contact in a manner in which there is no public or newsworthy purpose when the person knows or should have known that the depicted person is: (i) identifiable from the image itself or information displayed in connection with the image; and (ii) has not consented to the dissemination, display or publication of the private image.
- "Sex Trafficking or Aggravated Sex Trafficking" means to knowingly: (i) promote prostitution by compelling
 a person to enter into, engage in or remain in prostitution; (ii) promote prostitution of a person 15, 16 or 17
 years of age; or (iii) promote prostitution of a person who suffers from a mental disability that is reasonably
 apparent or known to the actor and that in fact renders the other person substantially incapable of
 appraising the nature of the conduct involved.
- "<u>Sexual Harassment</u>" means any unwelcome verbal or physical conduct of a sexual nature directed at a specific person, as well as retaliation for communicating about or filing a complaint of sexual harassment.

Intimate Partner Violence

<u>"Intimate Partner Violence"</u> means any act that constitutes abuse under <u>19-A MRS §4002(1)(A-H)</u> committed between individuals who are or have been in a social relationship of an intimate nature, regardless of whether the individuals were or are sexual partners. Conduct within the definition of intimate partner violence includes the following:

- Sexual Assault as defined in Section C. 2.a.1 herein.
- Attempting to cause or causing bodily injury or offensive physical contact;
- Attempting to place or placing another in fear of bodily injury through any course of conduct, including, but not limited to, threatening, harassing or tormenting behavior.
- Compelling a person by force, threat of force or intimidation to engage in conduct from which the person has a right or privilege to abstain or to abstain from conduct in which the person has a right to engage.
- Knowingly restricting substantially the movements of another person without that person's consent or other lawful authority: (i) removing that person from that person's residence, place of business or school; (ii) moving that person a substantial distance from the vicinity where that person was found; or (iii) confining that person for a substantial period either in the place where the restriction commences or in a place to which that person has been moved.
- Communicating to a person a threat to commit, or to cause to be committed, a crime of violence dangerous to human life against the person to whom the communication is made or another, and the natural and probable consequence of the threat, whether or not that consequence in fact occurs, is to place the person to whom the threat is communicated, or the person against whom the threat is made, in reasonable fear that the crime will be committed;
- Repeatedly and without reasonable cause following a person or being at or in the vicinity of the person's home, school, business or place of employment.

Stalking

<u>"Stalking,"</u> means intentionally or knowingly engaging in a course of conduct directed at or concerning a specific person that would cause a reasonable person to; i) suffer serious inconvenience or emotional distress, ii) fear bodily injury or fear bodily injury to a close relation; iii) fear death or fear the death of a close relation, iv) fear damage or destruction to or tampering with property, or v) fear injury to or the death of an animal owned by or in the possession and control of that specific person.

SUPPORTIVE MEASURES OFFERED AT THE TIME OF SEXUAL ASSAULT REPORT AND FORMAL COMPLAINT

Supportive measures are individualized, non-disciplinary services offered as appropriate and as reasonably available, without fee or charge. The measures are designed to restore or preserve equal access to an educational program or activity without unreasonably burdening the other party. Supportive measures may include counseling, extensions of deadlines or other course-related adjustments, modifications of work or housing locations, leaves of absence, increased security and monitoring of certain areas of the campus.

WCCC shall maintain confidentiality for any student receiving supportive measures that they receive, to the extent possible. The Title IX Coordinator will implement and monitor the supportive measures. Both the Title IX Coordinator or the Confidential Resource Advisor (CRA) may implement supportive measures.

COLLEGE PROCEDURE FOR DISCRIMINATION, HARASSMENT, SEXUAL HARASSMENT AND AFFIRMATIVE ACTION COMPLAINTS

Harassment, including sexual harassment, (hereinafter collectively called "harassment") and discrimination (including retaliation, intimidation and coercion) on the basis of race, color, national origin, age, ancestry, genetic information, sex, religion, veteran status, sexual orientation, including gender identity or expression, familial status and disability (hereinafter called "discrimination") are a violation of certain federal and/or state laws, as well as certain Maine Community College System ("MCCS") and WCCC policies. In addition, federal and/or state law require in some, and permit in other, instances the MCCS and Colleges to engage in affirmative action in its educational and employment activities. COLLEGE PROCEDURES FOR INVESTIGATING AND RESOLVING A SEXUAL MISCONDUCT COMPLAINT

Below is a summary of the process for allegations that meet the Title IX or Maine State Law definition of sexual misconduct. Allegations that meet Title IX definition must contain:

- Alleged conduct that constitutes sexual harassment if proved;
- Alleged conduct was against a person in the United States;
- Alleged conduct was against a person participating, or attempting to participate, in a WCCC educational program or activity; or
- Alleged conduct was at a WCCC location, during a WCCC activity or program, or when WCCC had substantial control over both the respondent and the context.
- Policy 202.2 provides the full definitions according to Title IX and Maine State Law.

Students, faculty, and staff are advised to report allegations of sexual harassment immediately, or as soon as possible. Reports can be made via mail, email, phone, web form, or in person.

A Confidential Resource Advisor ("CRA") is another source of information and emergency and ongoing support services available to students and employees. Seeking services from a CRA does not constitute a report, complaint or notice to the college of the alleged misconduct and does not initiate any action by the college. Further, the CRA is prohibited from reporting the incident to the college or law enforcement, unless required to do so by law or requested by the person seeking services.

If allegations meet that Title IX definition, then the ensuing investigation and resolution of a Title IX complaint will include the following elements:

- Supportive measures offered to a person at the time of a report
- Notice of formal complaint to the complainant and the respondent
- Emergency removal of respondent (if necessary)
- Informal resolution (only if both parties agree)
- Investigation: The investigation has 60 days from the filing of formal complaint to a draft report. Final report due to all parties 10 days before a live hearing.
- Live hearing
- Findings: Both parties shall be notified simultaneously in writing and provided with the written findings.
- Appeals: The president or designee shall simultaneously issue a written decision to both parties with the result of the appeal and the rationale for the decision.

The Decision Maker, in accordance with this Procedure and the MCCS Rules for Title IX Live Hearings and shall use the preponderance of the evidence standard.


MISSING PERSON PROCEDURE

The purpose of this procedure is to establish protocols for WCCC's response to reports of missing students, as required by the Higher Education Opportunity Act of 2008.

Emergency Contact: Residential students must provide information for an emergency contact.

Missing Student: A missing student is determined to be missing when the Dean of Enrollment Management and Student Services or designee determines that a student has been missing for more than 24 hours without any known reason.

Missing Residential Students: If a member of the WCCC campus community has reason to believe that a student who resides in on campus housing is missing they should immediately notify the Office of Residence Life or On-Call Professional phone at (207) 904-0194. The on-call professional staff will work with the Dean of Students Office to determine whether or not a student is missing. After investigating the missing person report, should the Office of Residence Life or member of the Dean of Enrollment Management and Student Services staff determines that the student is missing and all available means have been reached to contact the student including the emergency contact; the on-call professional will contact the Calais Police Department. If the missing student is under the age of 18 and is not emancipated, the Dean of Enrollment Management and Student Services or designee will notify the student's parent or legal guardian immediately.



HAZING PREVENTION & REPORTING

The Federal Stop Campus Hazing Act

Hazing is a violation of Maine Community College System policy, federal, and state law.

The Federal Stop Campus Hazing Act addresses reports of hazing by a student organization.

The Act defines hazing as: any intentional, knowing, or reckless act committed by a person (whether individually or in concert with other persons) against another person or persons, regardless of the willingness of such other person or persons to participate, that –

- is committed in the course of an initiation into, an affiliation with, or the maintenance of membership in, a student organization; and
- causes or creates a risk, above the reasonable risk encountered in the course of participation in the institution of higher education or the organization (such as the physical preparation necessary for participation in an athletic team), of physical or psychological injury.

The Act defines a student organization as: an organization at an institution of higher education (such as a club, society, association, varsity or junior varsity athletic team, club sports team, fraternity, sorority, band, or student government) in which two or more of the members are students enrolled at the institution of higher education, whether or not the organization is established or recognized by the institution.

Maine Community College System Prohibition of Injurious Hazing

Under Maine State Law Title 20-A M.R.S.A. §10004(2)(B), it is a violation of MCCS policy to engage in the injurious hazing of any student, employee, group, or entity affiliated with a college or the MCCS.

"Injurious hazing" means any action or situation on or off MCCS property that recklessly or intentionally endangers the mental or physical health of any such student, employee, group, or entity affiliated with a college or the MCCS.

Penalties

Pursuant to Maine State Law Title 20-A M.R.S.A. §10004(3), penalties for violating this policy include, but are not limited to, the following:

- 1. In the case of a person not associated with the institution, the removal of the violator from MCCS property;
- 2. In the case of a student or employee, suspension, expulsion, and/or other appropriate disciplinary action; and
- 3.In the case of an organization affiliated with a college or the MCCS, which authorizes hazing, rescission of permission for that organization to operate on MCCS property or receive any other benefit of affiliation with the MCCS or a college.

These penalties shall be in addition to any other MCCS or college rule of conduct, and to any civil or criminal penalty to which the violator(s) may be subject.

Investigating Incidents of Hazing

In compliance with the Federal Campus Hazing Act and Maine State Law, reports of hazing will be investigated by representatives from the Department of Student Services. Washington County Community College will publish a Campus Hazing Transparency Report documenting occurrences and will be updated every six months for the campus community. The College follows the Student Code of Conduct (Policy 501) and all applicable local, state, and federal laws for the reporting, investigating, and adjudication of hazing incidents.

Prevention & Bystander Intervention Strategies

Washington County Community College is committed to providing a safe and secure learning environment for all students, faculty, staff, and guests of the College. All registered student clubs and organizations receive annual hazing prevention training through the Director of Student Life Office.

ANNUAL FIRE SAFETY REPORT FOR RESIDENCE HALLS

Fire alarm pull stations are located throughout the hallways in all buildings on campus. These alarms are connected to the local fire department. Upon the ringing of the fire alarm, the building will be evacuated immediately in an orderly manner utilizing one of the exits located on the map. Each classroom, office, lab, shop area, and main corridor has a map with primary routes of exit. It is your responsibility to know these exits and alternative exits incase the primary exits are blocked by heavy smoke, or fire. Once outside the building, find concealment and cover in a safe area until an official all-clear message is received through the RAVE alert system. After receiving the all-clear, move to your designated rally point and determine if anyone from your classroom or office space is unaccounted for. Wait at your rally point until a critical response team member checks in with you. Report any missing persons to **(207) 454-1099**, when safe to do so. Each building has a designated rally point for evacuation which can found in each classroom, office, or shop.

If you see visible flames or smoke, or you're notified of such—Remain Calm.

- 1. Activate the nearest fire alarm pull station.
- 2. Close all doors and turn off lights as you leave.
- 3. Exit in an orderly fashion (walk) with no more than two people side-by-side. Do not run to exit building.
- 4. Do not jam or crowd exits.
- 5. Use stairwells for evacuation. Do not use the elevator for fire evacuations. If you cannot exit the building via a door, exit via a window, if safe, or call 911 and inform them of your location.
- 6. Persons with physical disabilities or those who are unable to navigate stairs should notify the nearest person and go to designated stairwell; if safe. Call 911 and let them know your location and that you cannot exit the building.
- 7. Should you become caught in heavy smoke, crouch down below smoke levels, take short breaths through your nose and crawl to the stairwell.
- 8. DO NOT re-enter the building until the fire department indicates it is safe.
- 9. Do not attempt to fight the fire unless it appears to be containable and you are trained in the use of an appropriate portable fire extinguisher. When using a fire extinguisher, remember the acronym PASS: Pull, Aim, Squeeze & Sweep.

Call the WCCC Emergency line at **1099** from a campus phone or **(207) 454-1099** from an off-campus phone, when safe to do so.

Fire Alarm: All alarms should be treated as an emergency.

Students are required to read and understand all fire evacuation procedures located on the back of their residence hall room door. In the event of a fire alarm, you should assume there is a fire and exit the building by the shortest route, as quickly as possible. You MUST remain outside the building and away from entrance eaves until the re-entry signal is given by college officials, or the Calais Fire Department. In all cases, the Calais Fire Department will be summoned to campus to inspect the residence hall. They will be assisted by the residential staff, which is trained in this area. Please note, residents are not allowed to return to the building once exited.

If you believe a resident is trapped in the building, please provide their name and location immediately to 911 or the professional staff member. **DO NOT REENTER the BUILDING!** Students are encouraged to contact their parents to let them know they are safe. The fire equipment provided in the residence halls (alarms, smoke and heat detectors, and extinguishers) is provided for use in emergency situations. Tampering with this equipment is a very serious matter and will lead to campus disciplinary action and possible legal action. Strict disciplinary action will be taken if a student is found in violation of fire safety regulations. In addition, any student who interferes or disobeys a local fire department official when in the building is subject to legal action. In each residence hall room there is a map for evacuation and a sticker with emergency numbers. These items should not be removed from the door or vandalized. If these items are tampered with, it will lead to campus disciplinary sanctions.

ANNUAL FIRE SAFETY

REPORT FOR RESIDENCE HALLS (CONTINUED)

Prohibited Fire Activities:

The Student Code of Conduct prohibits "conduct that disregards the welfare, health or safety of the College community, which includes, but is not limited to: 1) assault, harassment or intimidation; 2) false reports of fire or other dangerous conditions; 3) unauthorized use or possession of weapons, explosive components or chemicals, including fireworks, firearms, explosives, gas or compressed air; 4) disturbing authorized activities or the peaceful operation of the College; 5) use, possession, sale or distribution of alcoholic beverages or drugs as prohibited by law or College policy; 6) being under the influence or knowingly in the presence of drugs or alcohol while on College property or at College related events; 7) action prohibited by health or safety regulations; 8) creation of a fire hazard or other dangerous condition; 9) restriction of vehicular or pedestrian traffic flow into or out of College property or facilities; 10) action that produces mental or physical discomfort, embarrassment, harassment or ridicule to any member of the College community; 11) intentionally placing a person or persons in reasonable fear of physical harm; 12) lewd or indecent behavior; 13) tampering with fire or safety equipment; 14) parking violations; 15) disobeying the lawful order of College personnel; and/ or 16) any other conduct that threatens or endangers the health or safety of one's self or others. Students are prohibited from using portable electrical appliances that have open coils or open flames; smoking on campus; and any items with open flames.

All members of the WCCC community are encouraged to report any known residence hall fire circumstances to Facilities (Ext. 1067 or (207) 454-1067), the Director of Housing or Resident Assistant or a member of the Dean of Enrollment Management and Student Services at (207) 454-1000.

Fire Safety Equipment

At WCCC each of our residence halls has a fire suppression system, fire rated doors, an audible and visual alarm system, and is fully sprinkled. The fire alarm system is tested annually. In addition to the fire safety systems, every residence hall has fire extinguishers.

Supervised Fire Drills and Training

Supervised fire drills are conducted for each residence hall by WCCC staff. All residential professional staff receive fire safety and emergency action plan training and are responsible for covering these policies and procedures with residents during the opening community meetings.

Fire Safety

Fire safety equipment such as smoke detectors, sprinklers, fire extinguishers, fire alarm pull boxes, and emergency exit routing signs have been installed in the Residence Halls for your safety. These lifesaving items should never be tampered with. You will be found in violation of the Residence Hall Agreement and Student Code of Conduct if you tamper in any way with the fire safety equipment, or start a fire. You may be removed from campus housing. You will also be held responsible for any damage caused by tampering with the equipment or from starting a fire. Not only is this a violation of our policies, it is also a state law. If found in violation of tampering with fire safety equipment, you could also be reported to local authorities. Please note it is also a violation to not vacate any campus building during a fire alarm. Any time the alarm sounds, leave your apartment immediately following the evacuation route.

Residence Life Staff will instruct students on proper evacuation procedures at the first meeting of the year. You are encouraged to ask questions at any time if any procedure seems unclear. Students should leave by the nearest exit. If flame or smoke is blocking the nearest exit, occupants should be aware of their next available exit. You should exit the building completely. You must also move across the entrance path and wait on the opposite side of the fire lane until the Fire Department has inspected the building and approves re-entering the building.

Please be aware that the Calais Fire Department responds to all fire alarms and therefore fire lanes and the front of the entrance should remain clear at all times to provide the Fire Department with easy access to the buildings. The fire alarm sounds at the Calais Fire Department at the same time as the building alarm. Therefore, if everyone leaves the building immediately, the occupants should be out of the building before the Fire Department arrives at the scene.

ANNUAL FIRE SAFETY REPORT FOR RESIDENCE HALLS (CONTINUED)

Residence Hall Fire Statistics

WCCC takes all evidence of fires and burn marks very seriously. Each and every time a fire or burn markings are reported to Facilities an investigation is done. For purposes of compliance with the Higher Education Opportunity Act of 2008 the University is instructed to report every incident which meets the following definition of a fire.

For the purpose of fire safety reporting a fire is "any instance of open flame or other burnings in a place not intended to contain the burning or in an uncontrolled manner." The following statistics represent the total number of fires, the cause of each fire for each



residence hall. Separately each and every reported fire is individually explained at the end with the following information: Cause of the Fire, Number of Deaths related to the Fire, Number of Injuries that required Treatment at a Medical Facility, and Value of Property damage related to the Fire.

WCCC reported zero fires in on-campus student housing in 2024. Two fire drills were held in each student housing facility during the 2024-2025 academic year. Students were notified of fire safety information in their housing information packets.
